Welcome & Call to Order

New Business

NACRO membership parameters was lifted up to the Board by Adam Johnson. Jill (chair PD) brought forward the issue of whether to include the hours of ASG services needed for the workshops/courses offered through PD as part of the budget, or should they be included as overhead costs for the organization. Jill mentioned that ASG spent 100 hours on the mastery course offering. Roger noted that the costs of ASG services for should be delineated so that we know the true cost of the development and delivery of these courses. Roger recommended that Jill discuss this issue with VP Jessica (chair, finance) during their budget discussions.
